a) Information you provide to us

- Register to receive a service provided by us
- Contact us to request assistance, provide feedback, make a comment or complaint.

b) Information we receive from others about you

We may receive information about you from other organisations or agencies that we work with. This includes partner organisations, government bodies and service providers. This may be combined with other information you provided us with, to help improve our service to you.

Using your personal information

We may need to use some information about you to:

- deliver services and support to you;

You have the right to tell us:

- That you have removed your permission for us to contact you

- By telling us exactly what you are interested in, we can tailor our information to make it relevant to you. We understand everyone is busy and not always aware of what's going on, so we would love to be able to keep you updated.
- By giving us your permission, we can contact you when we are making changes or improvements to our services and when we have exciting news.

- We may also invite you to get involved in surveys or consultation opportunities to help us shape our services for the future.

Sharing your personal information

We will never sell your data, however we may share some of your personal information with partner organisations, for the following reasons:

- Our charity, health or Local Government partners in the process of delivering any contract we enter with them or you.
- If we are required to obtain additional professional or legal advice on a matter relating to you.
- To determine whether a grant or funding from a Government or other local, regional or national organisation (such as local Clinical Commissioning Groups) has been successful in achieving its targets and goals. The information provided for this would be in an aggregated and anonymised statistical format where an individual cannot be personally identified.

Storing your personal information

We will take all reasonable steps to ensure we keep your details safe, secure and used in accordance to this policy. We will use strict procedures and security features to prevent unauthorised access to your information.

While we will do our best to protect your personal information, there may be a situation that happens outside of our control that may affect you based on access to your data. We promise to act promptly and in accordance with the rules set out in the Data Protection Act 1998 and the General Data Protection Regulation (GDPR) to ensure any impact on you is minimised.

Your Rights
